**Re: Partial Refund of Tickets purchased for a Dressage Clinic with Isabell Werth**

We have been engaged as counsel by Isabell Werth and to act as an escrow agent in facilitating a partial refund to those persons who purchased a ticket to attend one of the dressage clinics with Isabell Werth originally scheduled to be held in Ontario from April 20 to April 22, 2018 and in Texas from October 12 to October 14, 2018 (the “Clinics”).

The Clinics were being organized by Danny Forbes who carries on business as DMF Productions. On short notice, DMF Productions announced that the initial Clinic scheduled to be held in Ontario was cancelled due to inclement weather and this Clinic has not been rescheduled. We advise that our client has terminated any association with DMF Productions and will not be participating in the Clinic organized by DMF Productions previously scheduled for Texas later this year or in any other event organized by DMF Productions.

Prior to the cancellation of the Clinic in Ontario, our client had received from DMF Productions part of the payment for her participation in these Clinics. Our client does not intend to retain any of these funds and wishes all of these funds to be applied to a partial reimbursement to those persons who purchased tickets for the Clinics although our client is under no legal obligation to act in this manner. These funds, less the cost of the reimbursement process, will be allocated pro rata among those persons who purchased the tickets and who sign and return the enclosed Acknowledgment and Release within the prescribed time. The exact amount of each person's the refund will be calculated when the number of participants has been determined and we will be in further contact with the participants at that time.

This partial refund is available to those persons who purchased a ticket for one of the Clinics and have not previously received a refund for the ticket. If you are eligible to participate in this partial refund, please would you sign and date the enclosed Acknowledgment and Release and return the same to this office by e-mail (lagrott@beardwinter.com), by fax (416-593-7760) or by regular mail to the address noted below marked to the attention of Cinzia Lagrotteria **before 5:00 p.m. (E.S.T.) on Friday, August 3, 2018**. Any Acknowledgements and Releases received at this office after this time will not entitle such persons to participate in this partial refund process.
